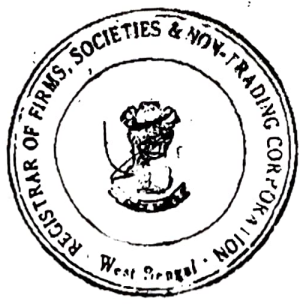

2. That the School authority shall implement the prescribed pay scales and allowances for the teaching and non-teaching staff of the school.
3. That the School authority shall provide retirement benefits to the teaching and non-teaching staff of the school as per a Death Cum Retirement Benefit Scheme.
4. That the managing committee of the school shall be constituted with at least three guardian members, three elected teacher members and one non-teaching staff. The Principal will be an Ex-officio member of the Managing Committee.
5. (a) That the school authority shall not enhance tuition fees or other charges without prior permission of the competent authority.  
(b) That the school shall not charge any capitation fee or equivalent to capitation fee by any means.
6. That the recruitment of teachers shall be done in accordance with transparent, merit – based criteria, to be laid down in the Memorandum of Parent Body and information thereof shall be made available to the State government, if necessary.
7. That the funds raised by the school authority, the fees collected and earned income by any other source, shall not be utilized for any other purpose than the welfare of the school and benefit of education of the students and the teaching and non-teaching staff of the school.
8. That no change in the ownership of the school or handing over of property or management of the school shall be done by any manner. Changing or amending the character of the Parent body shall not be done without prior notice to the State Government.
9. That service of the teaching and non-teaching staff shall not be terminated without giving opportunity of being heard by the competent authority and without observing due disciplinary proceedings.

10. That the service condition of the teaching and non-teaching staff including provisions of security of service, disciplinary proceedings and procedure for Appeal shall be implemented in accordance with the directions laid down in the Memorandum of the parent Body and submitted to the State Government.
11. That the school shall abide by procedure and rules and legal provision that may be promulgated in this regard.
12. That the school will pay its teaching and non-teaching staff emoluments at a rate which should not be less than those of their counterparts with equivalent educational qualifications in the State-aided educational institutions.
13. That the school will provide for contributory Provident fund for the employees as prescribed under relevant Provident Fund Act / rules of the Government of India.
14. That 10% (ten percent) of the new admission in the School in each academic year will be allowed on the recommendation of the School Education department and 50% of such students will have to be allowed to prosecute studies in the school free of any cost.
15. That the school shall have to furnish accurate and up-to-date statistical information relating to the functioning of the school and its academic activities as and when the same is called for by the Deputy Director of School education (AIS), West Bengal.
16. That violation of any of the conditions laid down in sub-para (2) to (15) shall entail withdrawal of the "No Objection" of the State Government with effect from the beginning of the academic year next to that in which the violation is committed.





- 2.The Interior finish decoration of building shall be made with low flame spread material conforming to the I.S. Specification.
- 3.To eliminate of fire hazard, Good Housekeeping both inside and outside of the building shall be strictly maintained.

- 4.Existing electrical wiring of the entire building shall have to be carefully checked for any wear and tear in them, particularly line above false ceiling & ducts.
- 5.The Exit Sign and fire notice shall be maintained from fading and dust sedimentation and prepared and displayed at all venerable place.
- 6.The employees and Security staffs shall be conversant with installed Fire Fighting Equipments of the building and operate in the event of fire and testing.
- 7.Mock Fire Practice and Evacuation Drill shall be performed periodically with participation of all the occupant of the building and same has to be informed to the local Fire Station positively.
- 8.Special training to employees and staffs shall be give for carrying the ambulant(s) to the safer place in the event of any exigency.
- 9.Meter and Main room shall be removed to outside of the building and be protected with CO2 or D.C.P. Modular Fire Extinguishers.
- 10.A Crew of trained fireman under an experienced officer shall be maintained round the clock for safety of the building and its occupants.
- 11.Fire License shall have to be obtained for storing and/processing with LPG and/ other highly inflammable articles.
- 12.Arrangement shall have to be made for regular checking, testing and maintenance of all the fire fighting installation in the building to keep them in perfectly good condition at all the time.
- 13.If required the old electrical lines shall have to be replaced with new ones in M. S. conduit laying continuously bonded to the earth.
- 14.Periodical flashing of water from the Landing valve and First Aid Fire Fighting Equipment shall be made to maintain the efficiency working performance of the Fire Fighting System Installed.
- 15.The Fire Safety Audit to be conducted at a regular interval and to be recorded in the Fire Prevention Maintenance Register.
- 16.At an interval of every six month, a report relating to the good working condition of the fire fighting installation and detection system and all electrical installation shall have to submit to the nearest Fire Station.
- 17.Outside the premises Addition and alternation constructions have to be regularised by taking Revised fire Safety Recommendation within 3 (three) month from issuance of RFSC. Fire Safety Certificate shall have to be obtained 3 (month) from date of issuance of this renewal of fire safety certificate, failing which if any untoward incident takes place , the concerned authority shall be solely responsible for the same .

The Fire Safety Certificate (FSC) Is valid for three years and has to be renewed as condition levied in para 17




